

MEMORANDUM OF UNDERSTANDING (MOU)

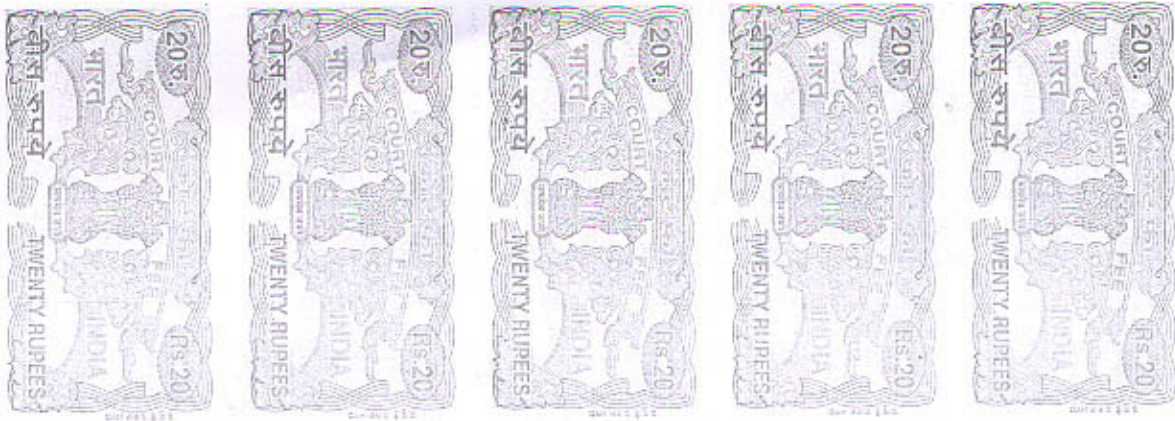
BETWEEN

A. M. HOSPITAL, KARUNAGAPALLY

AND

DEPARTMENT OF ENGLISH,

CHRISTIAN COLLEGE, CHENGANNUR



This memorandum of Understanding (MOU) is a service agreement to provide TRAINING to the employees of A.M. Hospital and PROFESSIONAL INTERNSHIP PROGRAM to PG students of the department of English between A.M. Hospital Karunagapally, a 90 bed multi specialty hospital, situated at Karunagapally, Kollam, Kerala, India and the Christian College, Chengannur.

To this end the parties operating under this MOU agrees as follows:-

- A. **PURPOSE:** A.M. Hospital is a medical care provider that has been at the forefront of providing affordable and quality healthcare to the general public from _____ to _____ in Kollam district.
- B. Christian College, Chengannur is owned and managed by Malankara Mar Thoma Syrian Church and is affiliated to the University of Kerala. Founded in 1964 by Rt. Rev. Dr. Mathews Mar Athanasius, Christian College, Chengannur towers high as a center of excellence in education on a hilltop with pristine beauty. The college always had it's focus on academic excellence and formation of character and emphasis on spread of spiritual truth and trust in God so as to produce intellectually well-trained, morally upright, socially conscious and spiritually inspired young men and women. The aim of the college is to provide higher education in the field of Arts & Science. It is aimed at encouraging sound learning, building character and upholding moral and spiritual values. Creation of employment oriented skills is an additional goal. The Department of English, Christian College, Chengannur believes in providing the industry with the requisite consultancy so as to enable them to function with greater efficiency and in securing Professional Internship programs that supplement and complement the Post Graduate Degree program in English.

The parties intend to enter into an MOU to Provide Professional Internship Program for the PG students of the English department of the College in association with A.M. Hospital as their knowledge and training partner.

- C. **PROGRAM:** The Department of English will provide the course content, train the hospital staff for the HOSPITAL EMPLOYEE TRAINING PROGRAM (HET PROGRAM). The (HET PROGRAM) consists of four modules

- I. **BASIC COMMUNICATION**
- II. **PROFESSIONAL ETTIQUETTE**

III. BEDSIDE MANNERS


IV. DEVELOPING EMPATHY AND THE RIGHT ATTITUDE

- D. A. M. Hospital shall assist Christian College, Chengannur to run the training program for their employees and facilitate the Professional Internship for the PG program students.
- E. **RESPONSIBILITIES:** Department of English, Christian college will be responsible to provide the content and trainers for the training of the employees of A.M. Hospital. The training content will be provided in English and Malayalam. The training will be provided through Activity –oriented and Skill development sessions aimed at providing On-the-Job Skill development training provided by the English department. The English Department will depute suitably qualified and experienced trainers to handle the sessions.
- F.
The PG students of the English Department, Christian College, Chengannur will be provided with Professional Internship by A.M. Hospital. A.M. Hospital will also let its brand be used to issue a co-branded certification from Christian College, Chengannur.
- G. **FINANCIAL AGREEMENT:** A.M. Hospital and Department of English, Christian College, Chengannur agree to bear the respective Training and Consultancy cost for Medical staff and the Professional Internship Program for students. A.M. Hospital agrees to provide PG students of English Department with Professional Internship in lieu of the Training for its Medical staff as per this MOU.
- H. **TERM:** Terms of the MOU shall be for the course of 6 months, commencing on the 1st of July 2017. The MOU can be renewed for a further period on terms agreed by the parties at that time.
- I. **TERMINATION:** This MOU may be terminated by either party by notice in writing from the party not at fault if the other party breach of this MOU and fails to remedy the breach within in thirty (30) days from the receipt of notice in writing from the first party specifying the breach
- J. **CONFIDENTIALITY OF INFORMATION:** The parties herewith undertake to treat confidentially all information that they obtain directly or indirectly from each other within the frame of the student mobilization and training engagement. Confidential treatment means that the information obtained may not be available to a third party and that the information may not be used for the parties' economic purposes or for the purposes of a third party. The parties undertake to use the information obtained solely for the purposes stipulated in the preamble. Any use going beyond that purpose or the conveying of information to a third party requires the written consent of both parties.

- K. FORCE MAJEURE:** Non-performance of either party (except payment obligation) shall be excused to the extent that performance is rendered impossible by strike, fire, flood, war, terrorism, act of God, government acts or orders or restrictions, failure of suppliers, or any other reason where failure to perform is beyond the control and not caused by the negligence of non-performing party.
- L. LANGUAGE:** The party hereto are satisfied that this MOU and all related documents be drawn for training purposes or any other purposes in the English language.
- M. ALTERATION:** Alterations and supplements to the MOU must be made in writing to hold validity
- N.** Neither of the party shall do any act which is unethical, immoral or against any prevailing or future Law of India
- O. CONDUCTING OF THE CLASSES:** For the PG students the Professional Internship shall be conducted during the summer vacation so as not to interfere with their regular classes. The training for the hospital staff shall be conducted in consultation with the hospital authorities. Both parties will designate a coordinator respectively to facilitate the program.

The exact date shall be finalized jointly by A.M. Hospital and Department of English Christian College, Chengannur before the actual training dates.
